#### **Legislative Chairman:**

Issues of Local, State and National importance:

Veterans Home for N. Idaho: We continue to work with the Idaho Division of Veterans Services to speed up their application for a new Veterans Home to be located on a site that has been donated in Post Falls. Representatives will be in Post Falls to review the site in the first week of August. NATIONAL ISSUES:

VA REFORM: We continue to support key reforms that are essential for building a healthy and robust VA health care system for the 21st Century. Congress must commit to provide the VA the resources it needs to modernize, rebuild and sustain its internal capacity to provide timely, high-quality health care. To better serve veterans, VA needs to restructure and consolidate all non-VA care programs into a single integrated Extended Care Network. VA must also realign and expand its health care services to meet the diverse needs of all generations of veterans, beginning with establishing new urgent care centers out in the community, and continue its extended operating hours. Finally, VA must reform its management culture through increased transparency and accountability.

<u>H.R. 341</u>: On January 14, 2015, Representative Ken Calvert introduced H.R. 341, a bill to require states to recognize the military experience of veterans when issuing licenses and credentials to veterans. <u>Military and Veteran Caregiver Services Improvement Act of 2015</u>

On April 23, 2015, Senator Murray introduced S. 1085, the Military and Veteran Caregiver Services Improvement Act of 2015, and Representative Langevin introduced a similar bill in the House, H.R. 1969. This important measure would extend to all veterans with a serious service-connected injury or illness eligibility to participate in the Department of Veterans Affairs (VA) program of comprehensive assistance to family caregivers of such veterans.

H.R. 303: On January 13, 2015, Rep. Gus Bilirakis (FL) introduced H.R. 303, the Retired Pay Restoration Act. This bill would end the unfair policy of forcing many military longevity retirees to forfeit some of their retired pay in order to receive equal amounts of disability compensation from the Department of Veterans Affairs (VA). The effect of this policy means military retirees are paying for their own disability with their military retired pay.

#### Women Veterans Access to Quality Care Act:

Senators Dean Heller and Patty Murray recently co-introduced S. 471, the Women Veterans Access to Quality Care Act. This bill is consistent with DAV's 2014 report, Women Veterans: the Long Journey Home; thus, the bill carries DAV's full support. The bill is also consistent with DAV National Resolution No. 040, passed by the delegates to our most recent National Convention.

The bill would improve VA facilities to better accommodate the needs of women veterans; would hold VA medical facility directors accountable to new performance measures focused on women veterans' needs; and, would ensure availability of obstetricians and gynecologists in all VA medical centers, among other provisions.

H.R. 969, the Blue Water Navy Vietnam Veterans Act of 2015, was introduced on February 3, 2015, by Representative Christopher Gibson (NY). This bill would amend title 38, United States Code, to expand the presumptions for service connection relating to the exposure to herbicides containing dioxin, including Agent Orange. This legislation would extend existing eligibility to certain veterans who served in the vicinity of the Republic of Vietnam, including the inland waterways, ports, harbors, and waters offshore or territorial seas of such Republic, as well as the airspace above. — Len Crosby, Legislative Chairman

**Finance Officer:** This month was amazing! We had an unexpected and very welcome donation from the Schneidmiller Family Foundation which dramatically increased our balance sheet. We also completed a very successful gun raffle which brought in more than \$3,500. A BIG THANK YOU to all of those members who coordinated the selling of raffle tickets and made this project a great success, especially Bryan Bledsoe and Charlie Till.

The Executive Committee agreed to invest a substantial portion of the Schneidmiller gift in prudent, safe and insured bank CD's. A portion of the donation will be invested in a more liquid money market account, to enable the Post to meet unforeseen expenses.

We should end the month of July with about six months of operating expenses in our bank account, which is an amazing accomplishment for a newly established Post.

In the past six months, the Post has contributed more than \$300 to local charitable organizations and more than \$300 to support youth activities. Additionally many of our members have contributed hundreds of hours of their time and talent to support local veterans, our Community and our youth.

As we closed out the month of June, we also filed a report with the City of Rathdrum detailing how we have used their generous "startup" contribution to acquire capital items needed to establish and operate our Post. – Len Crosby, Finance Officer

#### **Medal of Honor Highway**

The Medal of Honor Highway dedication took place in St Maries for Highway 3. The joint Honor Guard consisting of Post 154 and Post 143 members participated in the ceremony (Hal Donahue, Harold Markiewicz, Terrin Drapeau and Bryan Bledsoe). One of our other members, Lew Allert, represented DAV Fort Sherman Chapter #9 by bringing their flag and participating in the ceremony.

It was the epitome of small town Americana celebrating the 13 individuals who were in some way connected with North Idaho that had received the Medal of Honor dating from the Civil War up to present times. Three are connected to St Maries; Lloyd G McCarter, Pappy Boyington and Vernon Baker.

St Maries Community Band & Choir played and sang patriotic songs. The Marine Corps League posted colors, an invocation was given and Ron Derrick, American Legion Department Commander, gave the POW/MIA Ceremony in a dramatic and powerful way, explaining the significance of each article as it was placed on the table.

Post 25 Commander Jim Shubert gave a welcome to the 300 to 400 people assembled in the bleachers. His Post deserves great credit for the honor they gave to these brave military men.

Keynote speaker was Medal of Honor recipient Lt. Thomas Norris of Hayden. He gave a talk that was inclusive of all Medal of Honor recipients when he said that they were doing their job and did what needed to be done at the time with no thought of recognition or awards. Most received the award many years later and in many instances posthumously.

Coeur d'Alene Tribal elder and veteran, Calvin Nomi, gave a Smudge Blessing that was significant and meaningful. I doubt that any who attended will forget it. The tribal drum group Rose Creek played a ceremonial tribute to the National Anthem. Nomi then presented to Lt. Norris a handmade Tribal Warrior belt to honor his service and sacrifice. He had a bucket with earth and he asked each veteran to come up when the ceremony was over and take a handful, return it to the bucket and it would be spread from one end of the Highway 3 to the other. A long line of veterans came forward and paid their respects to Lt. Norris and Calvin Nomi.

Afterwards the Honor Guard was invited to have lunch and spend time with some of the dignitaries. Medal of Honor winner Thomas Norris sat at the table with our Honor Guard. It was something that none of us will forget.

It was a privilege to have been invited to attend and to participate in this great event celebrating our real American heroes. It was one of those feel good days. From our Post I saw Paula and Dale Atwood, and Lew and Carla Allert.

As we were driving back on Highway 3 we found Department Commander Ron Derrick along the side of the road assisting a stranded dad and his kids. They had run out of gas and had no money to buy any. Ron had gone to a gas station and gotten them some gas and his wife had given them some food. Once the car was started he filled up their tank at the gas station. He was a Good Samaritan and a Department Commander we can all be proud of. – Bryan Bledsoe, Adjutant

#### **Veterans Choice Program:**

Access health care closer to home

It has been explained to me that the Fee Basis program does not exist anymore and has been totally replaced by the Veterans Choice Program. It seems they are trying hard to make it work, but it is being applied to the letter of the law. In the west it is administered by Tri-West, a contractor. My personal experience with them has been positive.

The following FQA's will help you understand this new VA program:

If you are in doubt about your eligibility status please call the Choice Program Call Center at 866-606-8198.

#### Q: How can I confirm if I am eligible for the Choice Program?

A: Call the Choice Program Call Center at 866-606-8198 for more information.

#### Q: What happens once I have been determined as eligible?

A: Call the Choice Program Call Center at 866-606-8198 to set up an appointment.

#### Q: Can I call my non-VA doctor to make an appointment?

A: No, please call the Choice Program call center at 866-606-8198 to verify eligibility and make your appointment.

#### Q: How is the 40 mile calculation made?

A: This calculation is based on the distance from your permanent residence (or an active temporary address) to the closest VA facility-- including Community-Based Outpatient Clinics and VA Medical Centers.

## Q: If I am eligible for the Choice Program, can I receive Beneficiary Travel for travel to appointments with a Choice provider?

A: Yes, the Choice Act does provide the ability to pay for travel to the Choice preferred provider for Veterans who are eligible for Beneficiary Travel. However, the Choice Act did not provide any new Beneficiary Travel eligibility.

#### Q: I didn't get my Choice Card, what do I do?

A: You do not need your Choice Card to access the Choice Program. If you didn't receive a Choice Card, simply call 866-606-8198 to find out if you are eligible and to make an appointment.

#### Q: How do I get my prescription filled if I use the Choice Program?

A: The Choice Program non-VA Provider will issue a prescription with up to a 14 day supply of a National Formulary drug. You may have the 14 day supply prescription filled at any non-VA pharmacy of your choosing and may submit a request for reimbursement to VA. For prescriptions needed past 14 days, please follow standard procedures to fill a prescription at the VA pharmacy.

#### Q: If I use the Choice Program, does that affect my VA health care?

A: No, not at all. You do not have to choose between the two—the Choice Program is here to make it easier to access the care you need, close to home. .

#### Q: Is Emergency care covered by the Choice Program?

A: No, emergency care is not covered under the Choice Program. All care under the Choice Program is required to be preauthorized. VA has other options for you if you require emergency care. Please contact your local VA medical facility for more information.

Q: I live in Alaska/Hawaii, am I automatically eligible for the Choice Program?

A: Yes.

#### **Service Officer (cont.):**

#### Q: I live in New Hampshire, am I automatically eligible for the Choice Program?

A: If you live more than 20 miles from the White River Junction VA, you are eligible. If you live less than 20 miles from the White River Junction VA you are not eligible, based on the distance criteria.

Q: If I do not qualify for the Veterans Choice Program, are there other options I can use to access non-VA health care?

A: Yes, there are other non-VA care programs you may be able to use. Each program has its own eligibility requirements. Talk to your VA medical provider or click here for more details about these programs.

#### Q: My non-VA doctor is not part of the Choice Program, can he/she join?

A: Yes. VA is actively seeking to expand its network of community providers. Your doctor can call 866-606-8198 to learn more about the Veterans Choice Program and to become an approved Choice provider. If your preferred provider is not available under the Program, we will recommend other providers in your area. Your doctor can find more information here: http://goo.gl/iQrlsl

#### Q: Am I responsible for my private insurance deductible if I get care through the Choice Program?

A: Yes, if you are receiving non-service connected care. Your private health insurance will be the primary payer for non-service connected care and you may be responsible for the health insurance deductibles cost-shares. If you are receiving service connected care, you will not be responsible for your deductible as VA is primarily responsible for service connected care received through the Choice Program.

#### Q: What about VA copayments? Will they be collected by the community provider?

A: VA copays will be billed by VA after the appointment. If you currently pay VA copayments you will be subject to the same copayment requirements under the Choice Program. Your VA copay will be determined by VA after the care is provided.

#### Q: What if I don't have a VA copayment?

A: If you are VA copayment exempt then you will not be required to make the VA copayment under the Choice Program.

#### Q: Am I responsible for Medicare, Medicaid or TRICARE cost-shares?

A: No, these plans are not considered Other Health Insurance for purposes of the Choice Program. You will not be billed by the VCP provider for any of the cost-shares associated with these plans.

#### Fall 2014 Veterans Survey:




